RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST (this “Release”) is made as of March 16, 2020, by Wells Fargo Bank, National Association, in its capacity as administrative agent (in such capacity, the “Administrative Agent”) for the Lenders (as defined below), in favor of the Grantor (as defined below).

WITNESSETH:

WHEREAS the Lummi Tribe of the Lummi Reservation, Washington, also known as the Lummi Nation (the “Grantor”), executed that certain Loan Agreement, dated as of June 30, 2011, between the Grantor, as the borrower, the financial institutions party thereto from time to time (the “Lenders”) and the Administrative Agent (as amended, restated, supplemented or otherwise modified from time to time, the “Loan Agreement”);

WHEREAS pursuant to the terms of the Loan Agreement, the Grantor executed that certain Grant of Security Interest, dated as of June 30, 2011 (as amended, restated, supplemented or otherwise modified from time to time, the “Trademark Security Agreement”), in favor of the Administrative Agent, which was recorded in the United States Patent and Trademark Office at Trademark Reel 004573, Frame: 0278;

WHEREAS pursuant to the Trademark Security Agreement, the Grantor granted a security interest to the Administrative Agent in the Collateral (as defined in the Trademark Security Agreement); and


WHEREAS, the Administrative Agent has agreed to terminate and release the entirety of its security interest in the Collateral secured by the Trademark Security Agreement, including all of its liens on the trademarks and trademark applications of the Grantor identified on Annex 1 attached hereto and made a part hereof (the “Released Collateral”), and to reconvey any and all rights in the Released Collateral to the persons legally entitled thereto.

NOW, THEREFORE, in consideration of the promises and other good and valuable consideration, receipt of which is hereby acknowledged, the Administrative Agent hereby releases all of its rights in and to the Released Collateral, reconveys to the persons legally entitled thereto all of the Administrative Agent’s right, title and interest in and to the Released Collateral, all without warranty or representation of any kind.
