## RELEASE OF SECURITY INTEREST IN TRADEMARKS

Huntington consents and agrees to execute and deliver, at the request and cost of Company, such further instruments, documents and release forms as Company may reasonably request to more effectively release any such liens or interests in the identified trademarks, trademark registrations, and trademark applications.

This Release shall be binding upon Huntington's legal representatives, assigns, and successors.
