**ARTICLES OF MERGER  
OF  
WESTROCK COFFEE COMPANY, LLC  
WITH AND INTO  
WESTROCK COFFEE ROASTING, LLC**

February 28, 2020

Pursuant to Section 4-32-1208, et seq. of the Arkansas Small Business Entity Tax Pass Through Act, as amended (the "Arkansas Act"), Westrock Coffee Company, LLC, an Arkansas limited liability company (the "Merging Entity") and Westrock Coffee Roasting, LLC an Arkansas limited liability company and direct, wholly-owned subsidiary of the Merging Entity (the "Surviving Entity"), hereby submit the following Articles of Merger:

1. Entities. The parties to the merger (the "Merger") are (i) Westrock Coffee Roasting, LLC, an Arkansas limited liability company, and (ii) Westrock Coffee Company, LLC, an Arkansas limited liability company.

2. Surviving Entity. The name of the surviving limited liability company is Westrock Coffee Roasting, LLC, an Arkansas limited liability company.

3. Effective Time. The Merger is to become effective upon the filing of these Articles of Merger with the Arkansas Secretary of State.

4. Approval of Plan of Merger. The members of each of the Merging Entity and the Surviving Entity have approved that certain Agreement and Plan of Merger dated as of February 28, 2020, pursuant to which the Merging Entity shall be merged with and into the Surviving Entity, with the Surviving Entity continuing as the surviving limited liability company (the "Plan of Merger"), in accordance with Section 4-32-1207 of the Arkansas Act.

5. Approval of Agreement and Plan of Merger. The members of each of the Merging Entity and the Surviving Entity have approved the Merger in accordance with the terms of the Plan of Merger and the requirements of the Arkansas Act.

6. Copy of the Plan of Merger. A copy of the Plan of Merger is and will be kept on file at the place of business of the Surviving Entity, such office being located at 30 Collins Industrial Place, North Little Rock, Arkansas 72113. A copy of the Plan of Merger will be furnished by the Surviving Entity, on request and without cost, to any shareholder, member, partner or other owner of any party to the Merger.
