TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (“**Assignment**”), with an effective date of the last dated signature below (“**Effective Date**”), is made by and between HomeMe, Inc., a Delaware corporation with an address of 8509 Stellar Drive, Culver City, California 90232 (“**Assignor**”), and Homie, Inc., a Utah corporation with an address of 175 West 200, South #100, Salt Lake City, Utah 84101 (“**Assignee**”).

WHEREAS, Assignor owns U.S. Trademark Registration No. 3762332 (the “**Registration**”) for the mark HOMEY covering “providing real estate listings and real estate information via the Internet; providing an interactive online website that permits users to submit bids, schedule showings and request information for selected real estate properties” in Class 36 and “computer services, namely, providing an online search engine that enables users to access real estate listings and real estate information from a database according to user selected criteria” in Class 42 (the “**HOMEY Services**”);

WHEREAS, Assignor also owns common law rights in, and all the goodwill of the business associated with, the trademark HOMEY used in connection with the HOMEY Services (collectively with the Registration, the “**Mark**”);

WHEREAS, Assignor represents and warrants that it is using and has continuously used the Mark in commerce for all HOMEY Services since it acquired the Mark on April 15, 2016; and

WHEREAS, Assignee is desirous of acquiring all of Assignor’s right, title, and interest in and to the Mark and the goodwill associated therewith.

NOW, THEREFORE, for good and valuable consideration, including resolution of Cancellation Proceeding No. 92067785, the receipt and sufficiency of which Assignor acknowledges:

1. Assignor hereby assigns, and Assignee hereby accepts, all of its right, title, and interest in and to the Mark, together with the goodwill of the business symbolized by the Mark.
2. The Assignor also hereby covenants and agrees that the Assignor shall, at the request of Assignee or its counsel, execute, acknowledge and deliver all such further acts, deeds, assignments, transfers, powers of attorney and assurances as may be required to carry out the intent of this Assignment, and to transfer and vest all of Assignor’s right, title, and interest to and in the Mark and to procure, maintain, enforce and protect such right, title and interest; provided, however, this Assignment shall be effective regardless of whether any such additional documents are executed.
3. This Assignment shall be binding upon Assignor, Assignor’s successors and assigns.


