RELEASE OF SECURITY INTEREST IN TRADEMARK

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARK (this "Release") is made as of December 20, 2019 ("Effective Date") by ROSENTHAL & ROSENTHAL, INC., a New York corporation ("Grantee"), in favor of WILLIAM TODD ENGLISH, an individual ("Grantor").

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on June 28, 2013, at Reel 005058, Frame 0776; and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby releases its security interest against the Released Marks. Grantee shall, at Grantor's expense, take all further actions, and provide to Grantor, Grantor's successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release. This Release shall not constitute a release of Grantee's security interest in any other trademark and/or collateral under the Trademark Security Agreement, and the Trademark Security Agreement shall continue in full force and effect with respect to such other trademarks and/or collateral.
