TRADEMARK SECURITY AGREEMENT

This **TRADEMARK SECURITY AGREEMENT** (this “**Agreement**”), is made as of March 20, 2020 (the “**Effective Date**”) by and among MAVERICK GAMING LLC, a Nevada limited liability company (the “**Grantor**”) in favor of ANKURA TRUST COMPANY, LLC, a New Hampshire limited liability company, as the collateral agent (the “**Collateral Agent**”) for the secured parties under the Security Agreement referred to below (the “**Secured Parties**”).

WHEREAS, the Grantor and certain other borrowers have entered into a certain loan agreement, dated as of the Effective Date (as the same may be amended, modified, restated, replaced or superseded from time to time, the “**Loan Agreement**”), with the Collateral Agent and the administrative agent and lenders (the “**Lenders**”) party thereto.

WHEREAS, as a condition precedent to the making of the loan by the Lenders under the Loan Agreement, Grantor has executed and delivered to the Collateral Agent that certain Consolidated, Amended and Restated Senior Pledge And Security Agreement, dated as of the Effective Date made by and between the Grantor and the Collateral Agent (as the same may be amended, modified, restated, replaced or superseded from time to time, the “**Security Agreement**”).

WHEREAS, under the terms of the Security Agreement, Grantor has granted to the Collateral Agent, for the benefit of the Secured Parties, a security interest in, among other property, certain intellectual property of the Grantor, and

WHEREAS, Grantor and Collateral Agent have agreed to execute this Agreement for recording with the United States Patent and Trademark Office (the “**USPTO**”).

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Grant of Security Interest. To secure the performance of Grantor’s obligations under the Security Agreement, Grantor hereby grants to the Collateral Agent, for the benefit of the Secured Parties, a security interest in and to all of Grantor’s right, title, and interest in and to the United States trademark registrations and applications set forth in Schedule 1 hereto, together with the goodwill associated therewith or symbolized thereby (the “**Trademark Collateral**”); *provided*, that the foregoing grant of security interest shall not include any application for registration of a trademark that would be invalidated, canceled, voided or abandoned due to the grant or enforcement of such security interest, including United States intent-to-use trademark applications filed with the USPTO pursuant to 15 U.S.C. Section 1051(b) prior to the filing with, and acceptance by, the USPTO of a statement of use or amendment to allege use pursuant to 15 U.S.C. Section 1051(c) or (d), after which such application shall automatically be considered part of the Trademark Collateral.

2. Recordation. This Agreement has been executed and delivered by Grantor for the purpose of recording the grant of security interest herein with the USPTO. Grantor hereby

authorizes the Commissioner for Trademarks of the USPTO to record this Agreement upon request by the Collateral Agent against the Trademark Collateral.

3. Loan Documents. This Agreement has been entered into pursuant to and in conjunction with the Security Agreement, which is hereby incorporated by reference. The provisions of the Security Agreement shall supersede and control over any conflicting or inconsistent provision herein. The rights and remedies of the Collateral Agent with respect to the Trademark Collateral are as provided by the Loan Agreement, the Security Agreement, and related documents, and nothing in this Agreement shall be deemed to limit such rights and remedies.


4. Further Assistance. Upon termination or release of the security interest in the Trademark Collateral pursuant to the Loan Agreement and Security Agreement, the Collateral Agent shall execute and deliver to the Grantor an instrument in writing releasing the security interest in the Trademark Collateral for purposes of recordation with the USPTO, and shall take such other actions as Grantor shall reasonably request in writing to evidence such termination or release of the security interest in the Trademark Collateral.

5. Counterparts. This Agreement may be executed in one or more counterparts and by facsimile or electronic signature, each of which shall be deemed valid and an original, but all of which together shall constitute one and the same instrument.


