**RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of September 29, 2014 (“Release”), is made by **Citibank, N.A.**, a national association with offices at 1615 Brett Road, Ops III, New Castle, Delaware 19720, as Administrative Agent (“Administrative Agent”) in favor of **Lincoln Hockey LLC**, a Delaware limited liability company with offices at 627 North Glebe Road, Arlington, VA 22203 (“Debtor”).

WHEREAS, pursuant to those certain security agreements, including those dated as of June 9, 2010 and June 7, 2013 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the “Security Agreements”) and the Notices of Security Interest in Intellectual Property – Trademarks, including those also dated as of June 9, 2010 and June 7, 2013 (“Notices”), each by and among the Debtor and the Administrative Agent, Debtor granted to the Administrative Agent a continuing security interest in Debtor’s trademarks, including, but not limited to, those listed on Schedule A attached hereto (the “Trademarks”); and

WHEREAS, the Notices were recorded with the United States Patent and Trademark Office (“USPTO”) and the Canadian Intellectual Property Office (“CIPO”) including, without limitation, with the USPTO at Reel/Frame 4252/0067 and Reel/Frame 5044/0158, and with CIPO on August 23, 2010 on File No. 384168 against trademark registrations: TMA213885, TMA490237, TMA217248, TMA502065, TMA374093, TMA226313, TMA285041, TMA748168, and TMA748180; and

WHEREAS, the Administrative Agent desires to terminate all such security interests, and to execute and deliver to Debtor all deeds, assignments and other instruments as may be reasonably necessary to release the security interests relating to the Trademarks.


NOW, THEREFORE, for and in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Administrative Agent hereby terminates the Notices and the Security Agreements, and releases and relinquishes unto Debtor the continuing security interest in, and lien on, the Trademarks and otherwise assigns, grants and conveys to Debtor, without recourse, any and all right, title and interest the Administrative Agent may have in, to or under to the Trademarks in order to revest in Debtor full and unencumbered title to said Trademarks.
