**NOTICE OF TERMINATION AND RELEASE OF SECURITY INTEREST IN
TRADEMARKS**

This **NOTICE OF TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of March 18, 2020 (the “Release”), is made by **BANK OF AMERICA, N.A.**, as administrative agent for the lenders party to the Original Loan Agreement and Loan Agreement described below (in such capacity, the “Agent”), in favor of **KEEN, INC.**, a Delaware corporation (“Keen”), **FUERST GROUP, INC.**, a Delaware corporation (“Fuerst”), and **CHROME INDUSTRIES, INC.**, a California corporation (“Chrome”; together with Keen and Fuerst, each a “Grantor” and collectively, the “Grantors”).

WHEREAS, pursuant to that certain Loan and Security Agreement, dated as of February 27, 2009, by and among Keen, certain lenders party thereto and Agent (as modified from time to time, “Original Loan Agreement”), Keen granted and conveyed to Agent a security interest in the entire right, title and interest of Keen in and to all of Keen’s trademarks and trademark applications, including certain trademarks listed on Annex 1 hereto, as recorded in the United States Patent and Trademark Office on March 6, 2009 at Reel 3948 Frame 0036.

WHEREAS, pursuant to that certain Second Amended and Restated Loan and Security Agreement dated as of April 30, 2016 (as amended, restated, amended and restated, supplemented, modified, extended, renewed or replaced from time to time, the “Loan Agreement”) by and among the lenders from time to time party thereto, Agent and Grantors, each Grantor granted and conveyed to Agent a security interest in the entire right, title and interest of such Grantor in and to all of such Grantor’s trademarks and trademark applications, including those listed on Annex 1 attached hereto (collectively, the “Trademark Collateral”) as recorded in the United States Patent and Trademark Office on September 22, 2017 at Reel 6163 Frame 0372.

NOW THEREFORE, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Agent agrees as follows:

SECTION 1. Defined Terms. Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Loan Agreement.

SECTION 2. Termination and Release. Agent without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases all of its rights in, to and under, including its Lien on and security interest in, and right of setoff against, the Trademark Collateral, whether granted pursuant to (i) the Loan Agreement or any other agreement or document delivered in connection with the Loan Agreement, or (ii) the Original Loan Agreement or any other agreement or document delivered in connection with the Original Loan Agreement;

(b) reassigns any and all such right, title and interest (if any) that the Agent may have in, to and under the Trademark Collateral to the respective Grantor listed on Annex I;

(c) to the extent the same is necessary to effectuate the purposes hereof, authorizes the recordation of this Release with the U.S. Patent and Trademark Office, at Grantors' expense.


SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of California, without regard to its conflict of laws principles.
