**TERMINATION AND RELEASE OF  
TRADEMARK SECURITY AGREEMENT**

This Termination and Release of Trademark Security Agreement ("Release") is made as of March 20, 2020, by **THE NORTHERN TRUST COMPANY** an Illinois banking association (the "Lender") in favor of the **GRECIAN DELIGHT FOODS, INC.**, a Delaware corporation with an address at 1201 Tonne Road, Elk Grove Village, Illinois 60007 (the "Grantor").

WITNESSETH:

WHEREAS, the Grantor entered into a certain trademark security agreement dated November 17, 1993 (the "Trademark Security Agreement") with Lender, notice of which was recorded with the United States Patent and Trademark Office on November 19, 1993 at Reel 1095, Frame 0021.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, the Grantor granted the Lender, under the terms of the Trademark Security Agreement, a security interest (the "Security Interest") in favor of the Lender, in all of such Grantor's right, title and interest in, to and under its trademarks and all goodwill symbolized thereby, including without limitation the trademarks listed in Schedule A (collectively, the "Trademark Collateral").

WHEREAS, the Lender has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.


NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Lender, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges any and all of its interest in the Trademark Collateral of the Grantor, and assigns, transfers and conveys to Grantor the Security Interest in such Trademark Collateral. The Lender further hereby waives and relinquishes all its rights, powers, privileges and remedies with respect to the Grantor and its successors and assigns in association with the Security Interest, and hereby releases the Grantor and its successors and assigns from all covenants, obligations, liabilities and warranties in association with the Security Interest.
