**TRADEMARK ASSIGNMENT AGREEMENT**

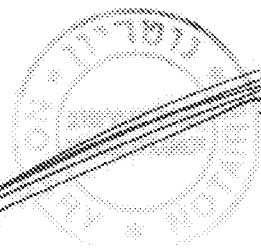
