## ASSIGNMENT OF TRADEMARKS

1. **Assignment and Assumption of Trademarks.**

A. **Assignor’s Assignment.** As of the Effective Date hereof, Assignor assigns and transfers to Assignee all of Assignor’s right, title, goodwill of the business and interest in and to the Trademarks.

B. **Assignee’s Assumption.** Assignee confirms that it is fully familiar with the Trademarks, and Assignee expressly assumes each and every obligation to maintain such Trademarks.


