MEMORANDUM OF TRADEMARK ASSIGNMENT

WHEREAS, on October 19, 2015 (the "Purported Assignment Date"), SIMON PROPERTY GROUP, L.P., a Delaware limited partnership ("SPGLP"), and, among others, WASHINGTON PRIME GROUP, L.P., an Indiana limited partnership ("WPG"), entered into that certain Trademark Assignment Agreement (the "Assignment") by which SPGLP purported to transfer and assign to WPG, among other things, all right, title and interest in and to the marks LAKELINE and LAKELINE MALL (the "Marks"), along with corresponding United States trademark registration no. 3,668,821 and Texas state trademark registration no. 801081752 (the "Registrations") and the goodwill of the business pertaining to the Marks;

WHEREAS, due to a scrivener's error, the Marks were inadvertently included as part of the Assignment from SPGLP to WPG, and thus the assignment of the Marks as purported in the Assignment was void *ab initio*;

WHEREAS, prior to and since the Purported Assignment Date, SPGLP has been and remains the owner of said Marks and Registrations;

WHEREAS, SPGLP and WPG desire to clarify the record to show that SPGLP now owns, and prior to and since the Purported Assignment Date has owned, all right, title and interest in and to said Marks, in both word and stylized forms, along with the goodwill of the business pertaining thereto and the Registrations; and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, WPG hereby executes this assignment to affirm that it does hereby transfer, convey, and assign to SPGLP all right, title and interest in and to the Marks, the Registrations, the goodwill of the business related to the services for which the Marks are used and registered, and to confirm that all rights WPG may have enjoyed in the Marks pursuant to the Assignment, were, in fact, owned and inured to the sole benefit of SPGLP, and to confirm that SPGLP has been the legal and equitable owner of the Marks, the Registrations, and the goodwill symbolized by the Marks.


