**Part 1: Trademark assignment**

**TRADE MARK ASSIGNMENT AGREEMENT**

**THIS TRADE MARK ASSIGNMENT AGREEMENT** (the "Agreement") is made on the 17th day of October 2019.

**BETWEEN**

(1) **BILLION SOFT (HONG KONG) LIMITED**, a company incorporated in Hong Kong and having its office at 15/F, 100 Queen's Road Central, Hong Kong and **Tommo, Inc.**, a company incorporated in the State of California, United States (each an "Assignor");

**AND**

(2) **ZIGGURAT INTERACTIVE, INC.** a company incorporated in the United States of America, state of Colorado, and having its office at 7424 S University Blvd, Unit #E 207, Centennial CO 80122 (the "Assignee"),

each a "Party", and together the "Parties", to this Agreement.

**BACKGROUND**

(A) Each Assignor is the owner of the trademarks, and the registrations thereof, in the country identified in the Schedule hereto (the "Trademarks").

(B) Each Assignor has agreed to assign the Trademarks to the Assignee upon the terms and conditions of this Agreement.

**IT IS HEREBY AGREED** as follows:

1. In consideration of the sum paid by the Assignee to each Assignor (the sufficiency and receipt of which such Assignor hereby acknowledges), each Assignor hereby assigns and transfers to the Assignee all of such Assignor's right, title and interest in and to the Trademarks (whether registered or unregistered) together with the whole of the goodwill in or to the Trademarks and including, without limitation, any rights to take action against any past infringement or breach in relation to the Trademarks.
2. Each Assignor shall, at the request, cost and expense of the Assignee, promptly take such actions (including, without limitation, the prompt execution and delivery of documents in recordable form or testifying as to any material fact or thing) as may be necessary to vest in, record and secure unto Assignee the full right, title and interest in and to the Trademarks and to protect and enforce the Trademarks.
3. The Parties agree that this Agreement shall be governed by the laws of the United States of America and the parties hereby submit to the exclusive jurisdiction of the courts of the United States of America.






