**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Trademark Release”), effective as of March 26, 2020, is made by CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH, as collateral agent (the “Collateral Agent”) in favor of Aurico Reports, LLC, an Illinois limited liability company (n/k/a CareerBuilder Employment Screening, LLC) (the “Pledgor”).

WITNESSETH:

WHEREAS, reference is made to the Collateral Agreement (First Lien), dated as of July 31, 2017 (as amended, restated, supplemented or otherwise modified from time to time, the “Collateral Agreement”), among CareerBuilder, LLC (the “Borrower”), the Pledgor, each other subsidiary of the Borrower identified therein and the Collateral Agent;

WHEREAS, pursuant to the Collateral Agreement, the Pledgor executed and delivered the Notice of Grant of Security Interest in Trademarks, dated as of July 31, 2017 (the “Trademark Security Agreement”) with Collateral Agent, which was recorded with the U.S. Patent and Trademark Office on July 31, 2017 at Reel/Frame No. 6118/0478;

WHEREAS, pursuant to the Trademark Security Agreement, the Pledgor granted and pledged to the Collateral Agent a continuing security interest in all of the Pledgor’s right, title and interest in, to and under the Trademark Collateral, including without limitation those Trademarks listed on Schedule I hereto;

WHEREAS, in reliance on the representations and certifications set forth in that certain Officer’s Certificate, dated March 26, 2020, made by the Borrower to the Collateral Agent concerning the permitted sale of the Pledgor, the Collateral Agent agrees to terminate and release its lien on and security interest in all such Trademark Collateral and has duly authorized the execution, delivery and performance of this Trademark Release.

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Collateral Agent agrees, for the benefit of the Pledgor, as follows:

SECTION 1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Trademark Release, including its preamble and recitals, have the meanings provided or provided by reference in the Collateral Agreement or the Trademark Security Agreement, as applicable.

SECTION 2. Release of Security Interest. The Collateral Agent, without any recourse, representation or warranty, does hereby release, relinquish, terminate and discharge its lien on and continuing security interest in the Trademark Collateral, and hereby assigns, transfers and conveys to the Pledgor, any right, title, or interest it may have in the Trademark Collateral.

SECTION 3. Termination. The Collateral Agent, without any recourse, representation or warranty, hereby terminates and cancels the Trademark Security Agreement.

SECTION 4. Further Assurances. The Collateral Agent hereby agrees to record this Trademark Release with the U.S. Patent and Trademark Office. The Collateral Agent further agrees to execute and deliver to the Pledgor any and all further documents and instruments, and do any and all further acts which the Pledgor (or its agents or designees) reasonably request (at the Pledgor's sole cost and expense) in order to confirm this Trademark Release and the Pledgor's right, title and interest in, to and under the Trademark Collateral.



This Trademark Release and the rights and obligations of the parties under this Trademark Release shall be construed in accordance with and governed by the laws of the State of New York, without regard to any principle of conflicts of law that could require the application of any other law.


SECTION 6. Counterparts. This Trademark Release may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original. Delivery of an executed counterpart to this Trademark Release by facsimile or other electronic transmission shall be as effective as delivery of a manually signed original.
