RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of March 9, 2020 by SAAI, LLC, as agent ("Agent"), in favor of GHS INTERACTIVE SECURITY, a Delaware limited liability company ("Company"). Capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement (as defined below).

WHEREAS, the Company entered into a certain security and pledge agreement dated July 2, 2018 (the "Security Agreement") with Agent (as successor to Arena Limited SPV, LLC), notice of which was recorded on July 2, 2018 at the United States Patent and Trademark Office at Reel 6370, Frame 0338.

WHEREAS, Company granted the Agent, under the terms of the Security Agreement, a continuing security interest in favor of the Agent, in all of its right, title and interest in and to the certain collateral, including without limitation the registered trademarks and trademark applications listed on Schedule I attached hereto and made a part hereof (the "Trademark Collateral").

WHEREAS, the Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.

NOW, THEREFORE, FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Agent hereby unconditionally and expressly releases, terminates, and extinguishes any and all of its right, title and interest in and to any and all liens and security interests it may have upon the Trademark Collateral.


