TRADEMARK ASSIGNMENT

This Trademark Assignment is effective, *nunc pro tunc*, as of March 12, 2018, by and between VoiceBox Technologies Corporation a corporation organized under the laws of Delaware located at 1980 NE 24th Street, Suite 100, Bellevue, Washington 98005 ("VoiceBox"); and Nuance Communications, Inc., a corporation organized under the laws of Massachusetts located at 1 Wayside Road, Burlington, Massachusetts 01803 ("Nuance").

WHEREAS, VoiceBox owns the trademark identified in Annex A (the "Mark"); and

WHEREAS, VoiceBox wishes to assign the Mark to Nuance.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, VoiceBox agrees as follows:

VoiceBox hereby transfers and assigns all of its right, title, and interest in and to the Mark, together with the goodwill associated therewith, to Nuance. Such assignment shall include all rights to recover for damages and profits and all other remedies and causes of action for past infringement, and any and all other rights of VoiceBox held and enjoyed by it at common law. Such assignment does not include any liens, damages, judgments, or any other liabilities relating or connected to the Mark incurred by VoiceBox prior to the effective date of this Trademark Assignment.

VoiceBox agrees, at Nuance's expense, to provide Nuance with assistance as reasonably required to vest or perfect Nuance's exclusive ownership of the Mark, and to cooperate with Nuance and to do all acts reasonably requested by Nuance to evidence, establish, procure, record, apply for, register, and protect Nuance's ownership interests therein within such time period(s) as is reasonably required to enable Nuance to timely preserve its rights in the United States or any other jurisdiction.

VoiceBox agrees not to challenge Nuance's ownership of the Mark.
