**RELEASE OF SECURITY INTEREST IN
INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this "Release") is dated as of March 27, 2020 by JPMORGAN CHASE BANK, N.A., as collateral agent (in such capacity, the "Collateral Agent"), in favor of Fancy Chap, Inc. (the "Grantor").

WITNESSETH

WHEREAS, the Grantor and the Collateral Agent entered into that certain Collateral Agreement dated as of November 14, 2018 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Collateral Agreement") by and among the Grantor, the other grantors from time to time party thereto and the Collateral Agent;

WHEREAS, pursuant to the Collateral Agreement, the Grantor executed and delivered to the Collateral Agent that certain Trademark Security Agreement dated as of December 31, 2019 (the "Intellectual Property Security Agreement") and recorded with the United States Patent and Trademark Office ("USPTO") on January 13, 2020 at Reel/Frame No. 6828/0757, pursuant to which the Grantor assigned, pledged and granted to the Collateral Agent, its successors and assigns, for the benefit of the Secured Parties (as defined in the Collateral Agreement), a security interest in all right, title and interest in or to any and all of the Trademark Collateral (as defined in the Trademark Security Agreement); and


WHEREAS, in connection with the payoff of the obligations secured by the Trademark Collateral, the Grantor has requested that the Collateral Agent release its security interest in all right, title and interest in and to the Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing, the Collateral Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title and interest in or to any and all of the Trademark Collateral, including the trademark registrations and trademark applications set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that the security interest in the Trademark Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Grantor, without recourse, representation or warranty, any and all right, title and interest that the Collateral Agent may have obtained in, to and under the Trademark Collateral under the Collateral Agreement or the Intellectual Property Security Agreement.
