Shareholders: The Shareholders as in effect immediately prior to the Effective Date

Articles: The Articles of Conversion, including the post-conversion Articles of Incorporation, attached to this Plan of Conversion

Effective Date: The Date the Articles of Conversion are filed with the Oregon Secretary of State

As of the Effective Date the Directors and Shareholders adopted the following Plan in accordance with ORS 60.472(3):

1. DE Corporation will automatically be converted into OR Corporation pursuant to ORS 64.472 etc. and Delaware General Corporation Law 266, without any further action.
2. All Shares and Shareholder will automatically become the Shares and Shareholders of the OR Corporation with the same ownership interests.
3. OR Corporation's Articles will be as set forth in the attached Articles.
4. For income tax purposes, the OR Corporation will continue with the same EIN and as the same taxpayer for all purposes.
5. The material terms and conditions of the Conversion are that: (i) the business of the DE Corporation will continue to be carried on by the OR Corporation and (ii) all of the rights and properties of the DE Corporation will be vested in the OR Corporation and all of the debts, liabilities, and obligations of the DE Corporation shall continue as debts, liabilities, and obligations of the OR Corporation.

6. At the Effective Date, by virtue of this Conversion and without any action on the part of the shareholders of the DE Corporation, all of the issued and outstanding shares of the DE Corporation existing immediately prior to the effective time of the Conversion will be converted into a 100% ownership interest in the OR Corporation, and no new interests in the OR Corporation will be issued in the Conversion in respect thereof.
