## RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

This RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (this “**Release**”), dated as of March 30, 2020, is made by Wells Fargo Credit, Inc. (the “**Secured Party**”), in favor of Weems Industries, Inc., an Iowa corporation (the “**Grantor**”) identified in that certain Patent and Trademark Security Agreement dated as of December 18, 2002 (as amended, restated, supplemented or otherwise modified from time to time, the “**Collateral Agreement**”) by and between the Grantor and the Secured Party.

### RECITALS

A. Pursuant to the Collateral Agreement, Grantor granted to the Secured Party, for the benefit of the Secured Party, a security interest in all of the Trademarks then owned or at any time thereafter acquired by such Grantor or in which such Grantor then had or at any time thereafter may have acquired any right, title or interest, as collateral security for the prompt and complete payment and performance when due (whether at the stated maturity, by acceleration or otherwise) of all Indebtedness.

B. Pursuant to the Collateral Agreement, Grantor executed and delivered to the Secured Party a Notice of Security Interest in Trademarks, dated as of December 18, 2002, recorded with the U.S. Patent and Trademark Office on February 26, 2003 at Reel/Frame 002678/0290, in to evidence the Grantor’s pledge to the Secured Party of the security interest in and to all of the right, title and interest of Grantor in, to and under the Trademarks, Registrations and Applications set forth therein.

C. Grantor requested that the Secured Party release, discharge, terminate and cancel its remaining security interest in and to the Trademark collateral, including but not limited to the trademark registrations and applications listed on *Schedule I* attached hereto, together with the goodwill connected with the use of and symbolized thereby and all extensions and renewals thereof (the “**Trademarks**”).

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party, without recourse, representation or warranty of any kind or nature, and at the Grantors’ sole cost and expense, hereby releases, discharges, terminates and cancels its remaining security interest in and to the Trademark Collateral, including but not limited to the Trademarks.

The Secured Party authorizes and requests that the Commissioner of Patents and Trademarks and any other applicable government officer record this Release.


Capitalized terms used but not defined herein shall have the meanings given to them in the Collateral Agreement.
