## RELEASE OF SECURITY INTEREST IN INTELLECUAL PROPERTY

This Release of Security Interest in Intellectual Property is made as of March 23, 2020, by Silicon Valley Bank, a California corporation (“**Bank**”) in favor of Hive9, Inc., a Delaware corporation (“**Grantor**”) with its principal place of business located at 1122 S. ### Recital
