ASSIGNMENT AGREEMENT

THIS ASSIGNMENT AGREEMENT (this "Assignment Agreement"), effective as of January 31, 2020, by and between the James L. Throneburg Master Trust U/A/D 8/2/11, a North Carolina revocable trust ("Assignor"), on the one hand, and Strategic Brand Growth, LLC, a Delaware limited liability company having a principal place of business at c/o Manorhaven Holdings, LLC, 120 Wall Street, New York, New York 10005 ("Assignee") on the other.

RECITALS

WHEREAS, Assignor was the owner of all right, title, and interest in and to the trademarks, service marks, and the associated registrations and applications for registration identified on Exhibit A (collectively, the "Trademarks"), and the works of authorship and the associated copyright registrations and applications for registration identified on Exhibit B (collectively, the "Works");

WHEREAS, Assignor assigned to Assignee all of Assignor's worldwide right, title, and interest in and to the Trademarks and Works pursuant to that certain IP Purchase Agreement having an effective date of January 31, 2020 (the "Purchase Agreement");

WHEREAS, Assignor and Assignee now wish to formalize the terms of the Purchase Agreement and record Assignee as the sole and exclusive owner of the Trademarks and Works with all appropriate worldwide agencies;

NOW, THEREFORE, in consideration of the promises and the mutual covenants and agreements contained herein and in the Purchase Agreement, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto hereby agree as follows:

1. Assignment of Trademarks.

1.1 Assignor hereby sells, assigns and transfers, and sets over unto Assignee, its successors and assigns, free of all encumbrances, all worldwide right, title and interest of Assignor in and to the Trademarks, including: (i) all of the goodwill associated or connected with the use of, and symbolized by, the Trademarks, (ii) all registrations obtained by Assignor for the Trademarks including all extensions and renewals thereof, (iii) the right to file any document to maintain the Trademarks and any associated registrations, (iv) all common law trademark and trade name rights in the Trademarks, (v) the right to file applications for registration of the Trademarks worldwide, and (vi) the right to sue for past, present and future infringement, dilution or other violation of the Trademarks and collect and retain all damages, settlements and proceeds recovered therefrom for its own use and behalf and for the use and behalf of its successors and assigns; the same to be held and enjoyed by Assignee, its successors and assigns, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment Agreement had not been made.

1.2 Assignor hereby authorizes the Commissioner for Trademarks of the United States Patent and Trademark Office and all other corresponding entities or agencies in any applicable government or country, to record Assignee as the owner of the Trademarks.

2. Assignment of Works.

2.1 Assignor hereby sells, assigns and transfers, and sets over unto Assignee, its successors and assigns, free of all encumbrances, all worldwide right, title and interest of Assignor in and to the Works, including: (i) all copyright registrations therefor; (ii) all worldwide copyright and moral rights therein (and any further registrations or applications relating thereto and any renewals and extensions thereof), including all rights of modification and attribution; and (iii) the right to sue for past infringement thereof and to recover all damages therefrom; the same to be held and enjoyed by Assignee, its successors and assigns, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment Agreement had not been made.

2.2 Assignor hereby authorizes the Register of Copyrights of the United States Copyright Office and all other corresponding entities or agencies in any applicable government or foreign countries, to record Assignee as the owner of all copyright registrations and applications for registration of the Works.

3. **Further Assurances.** Subject to Section 4 (b) of the Purchase Agreement, Assignor hereby agrees to perform such proper and additional acts and execute such additional documents as are deemed necessary by Assignee or the governmental agencies having jurisdiction over the Trademarks and Works to (i) obtain and enforce trademark, copyright, or other legal protection of any Trademarks, or Works in the United States or in a foreign country; (ii) give full effect to and perfect the rights of Assignee under this Assignment Agreement, including, but not limited to, executing all documents necessary to register in the name of Assignee the assignment of the Trademarks and Works with the appropriate government offices; and (iii) enforce Assignee's interest in the Trademarks and Works.

4. **Successors.** This Assignment Agreement shall be binding upon and inure to the benefit of the parties hereto and their respective successors and assigns.

5. **Counterparts.** This Assignment Agreement may be executed in one or more counterparts, each of which shall be deemed an original and all of which together shall constitute one and the same instrument.

6. **Governing Law.** This Assignment Agreement is to be governed by and construed in accordance with the laws of the state of North Carolina, without giving effect to the choice of law principles thereof, including all matters of construction, validity and performance.

7. **Amendments.** This Assignment Agreement may be modified or amended only by express agreement of the parties hereto in writing, assenting to such modification or amendment.
