**RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL**

This RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL, dated as of March 31, 2020 (this “Release”), is made by Ares Capital Corporation, as Collateral Agent, in favor of Pathway Vet Alliance LLC, a Delaware limited liability company with offices at 800 W Cesar Chavez St. B-100, Austin, TX 78701 (the “Grantor”). Capitalized terms not otherwise defined in this Release shall have the meanings provided or provided by reference in the Trademark Security Agreement (as defined below).

WHEREAS, pursuant to that certain Second Lien Credit Agreement, dated as of December 21, 2018, the Grantor and the Collateral Agent, among others, entered into that certain Second Lien Security Agreement, dated as of December 21, 2018 (as may have been amended, restated, amended and restated, supplemented or otherwise modified from time to time the “Security Agreement”);

WHEREAS, pursuant to the Security Agreement, Grantor executed and delivered that certain Trademark Security Agreement, dated as of December 21, 2018 (the “Trademark Security Agreement”), in favor of the Collateral Agent, which was recorded in the United States Patent and Trademark Office on December 21, 2018 at Reel 6507, Frame 0123;

WHEREAS, pursuant to the Security Agreement and the Trademark Security Agreement, as security for the payment or performance, as the case may be, in full of the Secured Obligations, the Grantor granted to the Collateral Agent, its successor and assigns, for the benefit of the Secured Parties, a continuing security interest (the “Security Interest”) in all of the Grantor’s right, title or interest in or to any and all of the Owned Trademarks, including those listed on Schedule I hereto, and all proceeds of the Owned Trademarks, then owned or at any time thereafter acquired by the Grantor or in which the Grantor then had or at any time thereafter may have acquired any right, title or interest, in each case, other than Excluded Assets (the “Trademark Collateral”); and

WHEREAS, the Grantor has requested that the Collateral Agent terminate and release its security interest in the Trademark Collateral.


NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent, hereby terminates, cancels and releases the Security Interest in the Trademark Collateral, without recourse to the Collateral Agent and without representation or warranty of any kind.

The Grantor (and any successor to the Grantor, including any person or entity hereafter holding any right, title or interest in and to the Trademark Collateral, is hereby authorized to record this Release with the United States Patent and Trademark Office.
