SCHEDULE A-2  
TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "Assignment") is made as of the Effective Date set forth below by Craig R. Jalbert as Assignee of DAI Holding, LLC (collectively, the "Assignor") and Potpourri Group, Inc. (hereinafter "Assignee").

NOW, THEREFORE, for good and valuable consideration (including the consideration recited in the Asset Purchase Agreement), the sufficiency of which is hereby acknowledged, Assignor makes the following assignment and agrees as follows:



2. MISCELLANEOUS. If any provision of this Assignment shall be adjudged by any court of competent jurisdiction to be unenforceable or invalid, that provision shall be limited or eliminated to the minimum extent necessary so that this Assignment shall otherwise remain in full force and effect and enforceable.

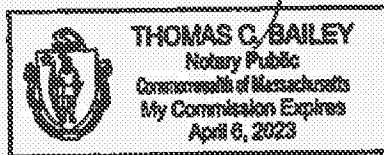
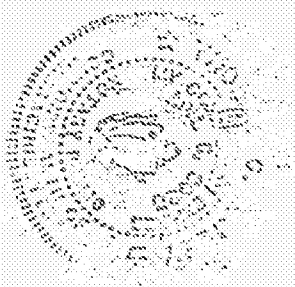
