**RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this “Release”), dated as of April 1, 2020 (the “Effective Date”), is made by CITIBANK, N.A., as administrative agent and collateral agent for the Secured Parties (in such capacities, the “Administrative Agent”) under that certain Revolving Credit Agreement, dated as of December 5, 2016 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time prior to the date hereof, the “Credit Agreement”), by and among, inter alios, SAL INTERMEDIATE HOLDCO CORP, SAL ACQUISITION CORP, MORAN FOODS, LLC (“Moran”), SAL MERGER SUB CORP, the lenders from time to time party thereto, and the Administrative Agent, in favor of Moran and the other Grantors (as defined in the Security Agreement referenced below).

WITNESSETH:

WHEREAS, pursuant to that certain ABL Pledge and Security Agreement, dated as of December 5, 2016 in favor the Collateral Agent (as amended, restated, amended and restated, supplemented or otherwise modified from time to time prior to the date hereof, the “Security Agreement”), Moran and the other grantors party thereto granted a security interest to the Collateral Agent for the benefit of the Secured Parties in certain collateral;

WHEREAS, pursuant to the Security Agreement, Moran executed and delivered a Trademark Security Agreement, dated as of December 5, 2016 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time prior to the date hereof, the “2016 Trademark Security Agreement”), for recording with the United States Patent and Trademark Office;

WHEREAS, pursuant to the Security Agreement, Moran executed and delivered a Trademark Security Agreement, dated as of September 16, 2019 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time prior to the date hereof, the “September 2019 Trademark Security Agreement”), for recording with the United States Patent and Trademark Office;

WHEREAS, pursuant to the Security Agreement, Moran executed and delivered a Trademark Security Agreement, dated as of October 16, 2019 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time prior to the date hereof, the “October 2019 Trademark Security Agreement”, and together with the 2016 Trademark Security Agreement and the September 2019 Trademark Security Agreement, collectively, the “Trademark Security Agreements”), for recording with the United States Patent and Trademark Office;

WHEREAS, the 2016 Trademark Security Agreement was recorded with the United States Patent and Trademark Office at Reel/Frame No. 5935/0207;

WHEREAS, the September 2019 Trademark Security Agreement was recorded with the United States Patent and Trademark Office at Reel/Frame No. 6749/0206; and

WHEREAS, the October 2019 Trademark Security Agreement was recorded with the United States Patent and Trademark Office at Reel/Frame No. 6773/0364.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined, herein shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement or the Trademark Security Agreements, as applicable.

2. Release. The Collateral Agent hereby releases, discharges, terminates, and cancels all of its security interest in and to the Trademark Collateral (including any Additional Collateral), including but not limited to the Trademarks and Trademark licenses set forth in Schedule A attached hereto, in each case arising under the Security Agreement and the Trademark Security Agreements. If and to the extent that the Collateral Agent has acquired any right, title, or interest in and to the Trademark Collateral (including any Additional Collateral) under any Trademark Security Agreement or the Security Agreement, the Collateral Agent hereby transfers, conveys, and assigns any and all such right, title or interest to Moran. The Collateral Agent authorizes and requests that this Release be recorded at the United States Patent and Trademark Office.

3. Termination. The Collateral Agent hereby terminates and cancels each Trademark Security Agreement.

4. Further Assurances. The Collateral Agent agrees to take all further actions, and to provide to Moran all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by, and at the sole expense of, Moran, to more fully and effectively effectuate the purposes of this Release.

5. Counterparts. This Release may be executed in any number of counterparts, all of which taken together shall constitute one agreement, and any of the parties hereto may execute this Release by signing any such counterpart. Moran acknowledges that delivery of an executed counterpart of a signature page of this Release by fax or electronic mail transmission shall be effective as delivery of a manually executed counterpart of this Release.

6. Severability. Any provision in this Release that is held to be inoperative, unenforceable or invalid in any jurisdiction shall, as to that jurisdiction, be inoperative, unenforceable or invalid without affecting the remaining provisions in that jurisdiction or the operation, enforceability or validity of that provision in any other jurisdiction, and to this end the provisions of this Release are declared to be severable.

7. Governing Law. This Release and any right, remedy, obligation, claim, controversy, dispute or cause of action (whether in contract, tort or otherwise) based upon, arising out of or relating to this Release shall be governed by, and construed in accordance with, the law of the State of New York.

8. Consent to jurisdiction. Each party hereto hereby irrevocably and unconditionally submits, for itself and its property, to the nonexclusive jurisdiction of the Supreme Court of the State of New York sitting in New York County and of the United States District Court of the Southern District of New York, and any appellate court from any thereof, in any action or proceeding arising out of or relating to this Release or any other Loan Document, or for recognition or enforcement of any judgment, and each of the parties hereto hereby irrevocably and unconditionally agrees that all claims in respect of any such action or proceeding may be heard and determined in such New York State or, to the extent permitted by law, in such Federal court. Each of the parties hereto agrees that a final judgment in any such action or proceeding shall be conclusive and may be enforced in other jurisdictions by suit on the judgment or in any other manner provided by law.


