Form of Release of Security Interest in Trademarks

Releasor further agrees to execute and deliver, at Releasee's sole expense, to Releasee any and all further documents or instruments and do any and all further acts which Releasee (or Releasee's agents or designees) reasonably request in order to confirm Releasee's right, title and interest in and to the IP Collateral.


