RELEASE OF SECURITY INTEREST IN TRADEMARK PROPERTY

THIS RELEASE OF SECURITY INTEREST IN TRADEMARK PROPERTY (this “*Release*”) is made effective March 10, 2020, by MONROE CAPITAL MANAGEMENT ADVISORS, LLC, as administrative agent (in such capacity, the “*Administrative Agent*”).

WHEREAS, reference is made to that certain Trademark Security Agreement dated June 30, 2017 (the “*Trademark Security Agreement*”), by and between APCO WORLDWIDE LLC (prior to the recordation of that certain Certificate of Conversion, recorded as of September 1, 2017, at Reel/Frame 6147/0502, APCO WORLDWIDE INC.) (“*Grantor*”) and Administrative Agent; all capitalized terms used herein but not otherwise defined herein shall have the meanings ascribed thereto in the Trademark Security Agreement; and

WHEREAS, under the Trademark Security Agreement, Grantor granted Administrative Agent a continuing security interest in all of the right, title and interest of Grantor in and to the Trademark property collateral identified therein (the “*Trademark Property Collateral*”); and

WHEREAS, the Trademark Security Agreement evidencing the security interest granted by the Grantor in favor of the Administrative Agent was recorded with the United States Patent and Trademark Office on July 10, 2017 with respect to the Trademark Property Collateral at Reel/Frame 6096/0610.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent hereby irrevocably and forever releases and terminates its security interest in and to the Trademark Property Collateral, including, without limitation, the intellectual property described in Schedule A attached hereto.


