RELEASE OF SECURITY INTEREST IN REGISTERED TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN REGISTERED TRADEMARKS (this “Release”) is made as of this 2nd day of April, 2020 (the “Effective Date”), by the undersigned former owners and managers (collectively, “Owners”) of WTH 2011, LLC (“Secured Party”) in favor of CardWorks, Inc. (“Grantor”).

Reference is hereby made to: (a) the Pledge and Security Agreement dated as of June 29, 2007 (as amended, the “Pledge Agreement”) between Grantor and the Secured Party; (b) to the obligations of Grantor to Secured Party under, and secured pursuant to, the Pledge Agreement (the “Secured Obligations”); (c) the Security Interest in Registered Trademarks dated as of March 29, 2011 (the “Trademark Security Agreement”) made by Grantor in favor of Secured Party; and (d) the Registered Trademarks under, and as defined in, the Trademark Security Agreement (the “Registered Trademarks”) which Registered Trademarks are listed on Schedule A attached hereto and made a part hereof.

Each of the Owners, individually and collectively, hereby certifies that: (i) the Secured Obligations have been repaid in full; (ii) the Pledge Agreement has terminated; (iii) the Trademark Security Agreement has terminated; (iv) there are no liens or security interests of any kind held by the Owners (or any of them) and/or the Secured Party in the Registered Trademarks; (v) the Owners, collectively, previously held all the voting ownership interests in, and comprised the entire board of managers of, the Secured Party; and (vi) the Secured Party was dissolved by a unanimous vote of the Owners on December 12, 2014 and a certificate of cancellation was filed with the Secretary of State of Delaware on December 15, 2014.

Each of the Owners, individually and collectively, hereby unconditionally and expressly releases, terminates, and extinguishes, on behalf of each of themselves and the Secured Party, all of its and their liens and security interests of any kind in or on the Registered Trademarks. Each of the Owners, individually and collectively, on behalf of each of themselves and the Secured Party, consents and agrees to execute and deliver, at the request and cost of Grantor, such further instruments, documents, and release forms as Grantor may reasonably request to more effectively, release, terminate and extinguish any liens and security interests in or on the Registered Trademarks.

Grantor hereby acknowledges and agrees that: (i) it has repaid the Secured Obligations in full; (ii) the Pledge Agreement has terminated; (iii) the Trademark Security Agreement has terminated; and (iv) there are no liens or security interests of any kind granted by Grantor in favor of the Owners and/or the Secured Party in the Registered Trademarks.

This Release may be executed in counterparts, including by pdf., facsimile, or other electronic means, each of which counterpart will be deemed an original. This Release shall be binding upon Grantor, each of the Owners, and its and their respective legal representatives, assigns and successors.


