TERMINATION AND RELEASE OF FIRST LIEN TRADEMARK SECURITY AGREEMENT

THIS TERMINATION AND RELEASE OF FIRST LIEN TRADEMARK SECURITY AGREEMENT (this "Termination"), is dated as of March 16, 2020, and made by CITIZENS BANK, N.A., as Collateral Agent (the "Grantee"), to US SALT, LLC, a Delaware limited liability company (the "Grantor").

WHEREAS, pursuant to that certain First Lien Trademark Security Agreement dated as of January 16, 2019 by the Grantor in favor of the Grantee (the "Security Agreement"), a security interest was granted by the Grantor to the Grantee in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, the Security Agreement was recorded at the United States Patent and Trademark Office on January 16, 2019 at Reel/Frame 6526/0005; and

WHEREAS, Grantee now desires to terminate and release the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, the Grantee hereby states as follows:


1. Definitions. The term "Trademark Collateral" as used herein, shall have the meaning set forth in the Security Agreement, and includes all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the trademarks, trademark registrations, and trademark applications listed on Schedule A hereto.

2. Release of Security Interest. Grantee hereby terminates the Security Agreement, terminates, releases and discharges its lien and security interest in and to the Trademark Collateral and reassigns to Grantor any and all right, title and interest of Grantee in the Trademark Collateral. Grantee authorizes the recordation of this Termination with the United States Patent and Trademark Office.
