TRADEMARK ASSIGNMENT AGREEMENT

The Assigned Trademark shall be held and enjoyed by Assignee, its successors and assigns as fully and entirely as the same would have been held and enjoyed by Assignor had this Assignment not been made.

Assignor covenants and agrees to execute such further and confirmatory assignments in recordable form as Assignee may reasonably require and prepare to vest record title of the Assigned Trademark in Assignee, at Assignee's request and at Assignee's sole expense.

This Assignment may be executed in two or more counterparts, each of which shall be deemed to be an original and all of which together shall be deemed to be one and the same instrument. Copies of executed counterparts transmitted by telecopy, fax, "portable document format" (.pdf), or other electronic transmission service shall be considered original executed counterparts.
