ASSIGNMENT OF TRADEMARKS, TRADE NAMES, AND SERVICE MARKS

This Assignment of Trademarks (“Assignment”) is made effective as of April 3, 2020 by LUCKY’S MARKET PARENT COMPANY, LLC, a Delaware limited liability company (“Lucky’s”) and the entities listed on Schedule 1.1-1 of the Asset Purchase Agreement dated April 3, 2020 (the “Purchase Agreement”), each of which is directly or indirectly owned by, or under common ownership with, Lucky’s (collectively with Lucky’s, the “Assignors” and, individually, an “Assignor”) and SALTZMAN CONCEPT, LLC, an Ohio limited liability company and a wholly owned subsidiary of Dave’s Supermarket, Inc. an Ohio corporation, or its designee or assignee, as permitted under Section 22.2 of the Purchase Agreement (“Assignee”).

This Assignment is to evidence the following agreements and understandings:

RECITALS

A. Assignor is the sole owner of those trademarks and service marks listed on Exhibit A attached and made a part hereto, and other derivatives thereof, as such may be registered with the Ohio Secretary of State, the United States Patent and Trademark Office, or may be unregistered or common law trademarks, or service marks (collectively, the “IP”).

B. Pursuant to the Purchase Agreement by and between Assignor, as seller, and Assignee, as purchaser, Assignee is purchasing certain assets of Assignor, including the IP and all goodwill associated therewith.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:

Assignor hereby sells, assigns, transfers and sets over unto Assignee the exclusive right, title and interest in and to the IP and the use thereof throughout the world, together with the goodwill pertaining to the IP.

Assignor covenants and agrees to execute and deliver to Assignee, upon request, all such further documents, instruments and other writings which Assignee reasonably requests to effectuate the assignments set forth herein and/or to effectuate a registration of the IP as a trade name, trademark, service mark, or otherwise with any governmental entity.

This Assignment shall be governed by and construed in accordance with the laws of the State of Ohio. Any legal suit, action or proceeding arising out of or based upon this Assignment must be instituted in a state or federal court of record sitting in Cuyahoga County, Ohio, and the parties’ consent to the jurisdiction and venue of such court.



This Assignment may be executed in any number of counterparts, each of which will be deemed an original, but all of which together will constitute one and the same instrument.






