INTELLECTUAL PROPERTY ASSIGNMENT

Effective as of the Effective Date, Assignor does hereby sell, assign, transfer and convey to Assignee the entire right, title and interest in and to the Trademark, and any and all past, present, and future filings, applications, continuations, divisions, renewals, and extensions thereof or associated therewith, and any and all registrations of the foregoing throughout the world, and any and all past, present and future common law rights associated with or arising in connection with any of the foregoing throughout the world, together with all of the goodwill of any business and the operations of any business symbolized by or associated therewith, and trade secret and know-how rights associated therewith, for Assignee's full use and enjoyment, including the right to sue for and collect past, present, and future damages, income, royalties, and payments now or hereafter due and/or payable with respect to the Trademark, including but not limited to the collection of damages and payments in connection with any past, present and future infringement or other violation of the Trademark, and Assignee does hereby accept such assignments, transfers and conveyances as of the Effective Date.


