
WHEREAS, Assignor has adopted, owns and is using the Mark in connection with various goods and services; and



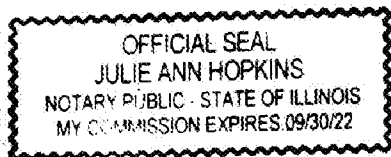
