GRANT OF TRADEMARK SECURITY INTEREST

THIS GRANT OF TRADEMARK SECURITY INTEREST (this "Instrument") is made March 4, 2020 by The Maids Holdings Inc., a Delaware corporation ("Holdings"), The Maids International, LLC, a Nebraska limited liability company ("Maids Operating") and TMI STORE HOLDING COMPANY LLC, a Nebraska limited liability company ("Company Store") in favor of Gladstone Investment Corporation, a Delaware corporation (collectively, together with its successors and assigns, "Secured Party").

RECITAL

Holdings, Maids Operating and Company Store (collectively, "Grantors") own and use in their respective businesses, and will in the future adopt and so use, various intangible assets, including the Trademark Collateral defined below. Secured Party has agreed to extend certain financial accommodations to Maids Operating and Company Store pursuant to a certain Note Purchase Agreement of even date herewith (as amended, restated, supplemented or otherwise modified from time to time, the "Note Purchase Agreement"). Holdings has agreed to guaranty the payment and performance obligations of Maids Operating and Company Store under the Note Purchase Agreement pursuant to a certain Guaranty of even date herewith made by Holdings in favor of Secured Party (as amended, restated, supplemented or otherwise modified from time to time, the "Guaranty"). To secure their respective obligations under the Note Purchase Agreement and Guaranty, Grantors have created in favor of Secured Party a security interest in, and Secured Party has become a secured creditor with respect to, among other things, the Trademark Collateral, pursuant to the terms of a certain Security Agreement of even date herewith among Grantors and GAIN (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"). In furtherance of the security interest in the Trademark Collateral granted pursuant to the Security Agreement, Grantors desire to execute this Instrument in favor of Secured Party. Capitalized terms used but not defined herein shall have the meanings assigned to them in the Security Agreement.

AGREEMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, subject to the terms and conditions of the Security Agreement, to evidence further the security interest granted by Grantors to Secured Party pursuant to the Security Agreement, Grantors hereby grant to Secured Party a security interest in all of Grantors' right, title and interest in and to the following (unless constituting Excluded Collateral), in each case whether now or hereafter existing or in which Grantor now has or hereafter acquires an interest and wherever the same may be located (the "Trademark Collateral"):

(a) all rights, title and interests (including rights acquired pursuant to a license or otherwise) in and to all trademarks, service marks, designs, logos, indicia, trade names, trade dress, corporate names, company names, business names, fictitious business names, trade styles and/or other source and/or business identifiers and applications pertaining thereto, owned by such Grantor, or hereafter adopted and used, in its business (including, without limitation, the trademarks set forth on *Schedule A* annexed hereto) (collectively, the "Trademarks"), all registrations that have been or may hereafter be issued or applied for thereon in the United States and any state thereof and in foreign countries (including, without limitation, the registrations and applications set forth on *Schedule A* annexed hereto), all common law and other rights (but in no event any of the obligations) in and to the Trademarks in the United States and any state thereof and in foreign countries and all goodwill of such Grantor's business symbolized by the Trademarks and associated therewith; and

(b) all proceeds, products, rents and profits of or from any and all of the foregoing Trademark Collateral and, to the extent not otherwise included, all payments under insurance (whether or not Secured

Party is the loss payee thereof), or any indemnity, warranty or guaranty, payable by reason of loss or damage to or otherwise with respect to any of the foregoing Trademark Collateral. For purposes of this Grant of Trademark Security Interest, the term "proceeds" shall have the meaning assigned to the term "Proceeds" in the UCC.

Grantor does hereby further acknowledge and affirm that the rights and remedies of Secured Party with respect to the security interest in the Trademark Collateral granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.
