RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

This **RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL**, dated as of April 8, 2020 (the "Release"), is made by MORGAN STANLEY SENIOR FUNDING, INC., in its capacity as collateral agent for the secured parties (in such capacity, the "Collateral Agent"), in favor of GOLF ACQUIROR LLC, a Delaware limited liability company (the "Grantor"). All capitalized terms used but not otherwise defined herein have the meanings assigned to them in the Collateral Agreement hereinafter defined.

WITNESSETH

WHEREAS, the Grantor and the Collateral Agent are parties to that certain Collateral Agreement, dated as of December 11, 2019 (as amended, amended and restated, supplemented, waived, renewed, replaced or otherwise modified from time to time, the "Collateral Agreement");

WHEREAS, pursuant to the Collateral Agreement, the Grantor executed a Trademark Security Agreement, dated as of January 10, 2020 (the "Trademark Security Agreement") and recorded with the U.S. Patent and Trademark Office on January 10, 2020 at Reel/Frame No. 6835/0510, pursuant to which the Grantor pledged and granted to the Collateral Agent for the benefit of the Secured Parties a continuing first-priority lien and security interest in and to all of its right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement).


WHEREAS, the Grantor has requested that the Collateral Agent release its security interest in all right, title and interest in, to and under all of the Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing, the Collateral Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title and interest in, to and under all of the Trademark Collateral, including the trademark registrations set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest in the Trademark Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Grantor, without recourse, representation or warranty, any and all right, title and interest that the Collateral Agent may have obtained in, to and under the Trademark Collateral under the Collateral Agreement and the Trademark Security Agreement.
