FOREIGN CORPORATION INTO
A DOMESTIC CORPORATION**

Pursuant to Title 8, Section 252 of the Delaware General Corporation Law, the undersigned corporation executed the following Certificate of Merger:

FIRST: The name of the surviving corporation is XPO Logistics Supply Chain Holding Company, a Delaware corporation, and the name of the corporation being merged into this surviving corporation is XPO Supply Chain, Inc., a North Carolina corporation.
