TRADEMARK ASSIGNMENT

 - (e) all rights to sue for past, present and future infringement, dilution or violation of any of such rights, and all of Assignors' claims against any third parties relating thereto, known or unknown, contingent or non-contingent.
2. Each Assignor hereby authorizes the Commissioner for Trademarks in the United States Patent and Trademark Office to record and register this Trademark Assignment upon request by Assignee. Each Assignor shall, from time to time and as necessary, execute and deliver to Assignee all agreements and other documents reasonably necessary to give effect to this Trademark Assignment.
3. This Trademark Assignment shall be governed by and construed in accordance with the Laws of the State of Texas, without giving effect to any choice of law or conflict of law provision or rule (whether of the State of Texas or any other jurisdiction) that would cause the application of the laws of any jurisdiction other than the State of Texas.
