Assignor irrevocably sells, assigns, transfers, and delivers to Assignee all of its rights, title and interest in and to the Marks, including all rights to file for foreign registrations thereof, and the goodwill of the business symbolized thereby and associated therewith. Assignor further assigns to Assignee any and all rights to royalties, profits, compensations, license fees or other payments or remuneration of any kind relating to the Marks, the right to sue, bring actions and recover and hold damages, profits and other compensation for any and all past, present and future infringements and unauthorized uses of the Marks.

The Assignor covenants and agrees that Assignor shall, at the request of Assignee or its counsel, execute, acknowledge and deliver all such further acts, deeds, assignments, transfers, powers of attorney and assurances as may be required to carry out the intent of this Assignment, and to transfer and vest title to and in the Marks and to procure, maintain, enforce and protect the right, title and interest in and enjoyment of the Marks assigned, transferred and conveyed to Assignee pursuant to this Assignment; provided, however, this Assignment shall be effective regardless of whether any such additional documents are executed.

This Assignment shall be binding upon and shall inure to the benefit of the Assignor and Assignee and their respective successors, legal representatives and assigns, and all others acting by, through, with or under the Assignor's direction and all those in privity therewith.
