1. Assignment. 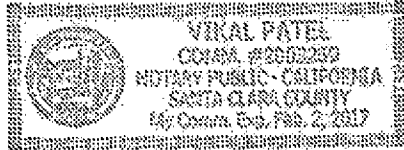


