ARTICLES OF CONVERSION
OF

TO THE SECRETARY OF STATE
OF THE STATE OF IOWA:

Pursuant to Section 1111 of the Iowa Business Corporation Act, the undersigned, Albaugh, Inc. (the "Converting Entity") elects to convert to an Iowa limited liability company, as permitted under the Section 1006 of the Iowa Revised Uniform Limited Liability Company Act, to be known as Albaugh, LLC (the "Company").
