**SECOND AMENDMENT
TO
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This Second Amendment to Intellectual Property Security Agreement is entered into as of January 22, 2020 (the "Amendment") by and between **COMERICA BANK** ("Bank") and **LAUNCHPOINT VENTURES, LLC**, a Delaware limited liability company ("Grantor").

RECITALS

Grantor and Bank are parties to that certain Intellectual Property Security Agreement dated as of August 23, 2017, as amended from time to time, including by that certain First Amendment to Intellectual Property Security Agreement dated as of September 10, 2018 (the "IPSA"). The parties desire to further amend the IPSA in accordance with the terms of this Amendment.

NOW, THEREFORE, the parties agree as follows:

1. Exhibit A (Copyrights) to the IPSA is hereby amended by adding those Copyrights listed on Exhibit A attached hereto.

2. Exhibit C (Trademarks) to the IPSA is hereby amended by adding those Trademarks listed on Exhibit C attached hereto.

3. Unless otherwise defined, all initially capitalized terms in this Amendment shall be as defined in the IPSA. The IPSA, as amended hereby, shall be and remain in full force and effect in accordance with its respective terms and hereby is ratified and confirmed in all respects. Except as expressly set forth herein, the execution, delivery, and performance of this Amendment shall not operate as a waiver of, or as an amendment of, any right, power, or remedy of Bank under the IPSA, as in effect prior to the date hereof. Grantor ratifies and reaffirms the continuing effectiveness of all agreements entered into in connection with the IPSA.

4. This Amendment may be executed in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one instrument.


