2. Warrant that Assignor has not knowingly conveyed to others any right in the Trademark or any license to use the same or to make, use or sell anything embodying or utilizing the Trademark; and that Assignor has good right to assign the same to Assignee without encumbrance; and

3. Bind Assignor's heirs, legal representatives and assigns, as well as Assignor, to do, upon Assignee's request and at Assignee's expense, but without additional consideration to Assignor or Assignee, all acts reasonably serving to assure that the Trademark remains in force.
