**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (this “Release”) is made this 10th day of April, 2020, by Fulton Bank, N.A. (the “Grantee”), in favor of B & E Poultry, Inc. (“Grantor”).

WHEREAS, pursuant to the terms and conditions of that Trademark Security Agreement by Grantor in favor of the Grantee, dated as of March 20, 2014 (the “Trademark Security Agreement”), Grantor granted to the Grantee a continuing security interest in all of Grantor’s right, title and interest in, to and under certain collateral, including but not limited to, the Trademark Collateral (as defined in the Trademark Security Agreement);

WHEREAS, reference is made to a certain Confirmatory Grant of Security Interest in Trademarks dated March 20, 2014 (the “Confirmatory Grant”) by Grantor in favor of the Grantee;

WHEREAS, in connection with the Trademark Security Agreement, Grantor granted to the Grantee a security interest in its Trademark Collateral, including without limitation the Trademarks set forth in Exhibit A hereof; and

WHEREAS, the Confirmatory Grant was recorded with the USPTO on March 21, 2014 at Reel/Frame 005241/0202 with respect to Trademark Collateral;

WHEREAS, Grantor’s obligations under the Trademark Security Agreement, and any related agreement, have been satisfied in full;

WHEREAS, the parties hereto desire to confirm and evidence the termination and release of the security interest in, to and under the Trademark Collateral.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantee, on behalf of itself and its successors, legal representatives and assigns, hereby unconditionally, irrevocably and absolutely, without recourse to or representation or warranty of any kind by the Grantee, (i) assigns to Grantor all of the Grantee’s right, title and interest (if any) in and to the Trademark Collateral and (ii) terminates, cancels, releases and forever discharges any and all security interests it holds in, to and under the Trademark Collateral, including, without limitation, the trademarks set forth on Exhibit A.

The Grantee shall take all further reasonable actions, and provide to Grantor or its successors, assigns or other legal representatives, all such reasonable cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by Grantor to more fully and effectively effectuate the purposes of this Release, in each case, at Grantor’s expense. By this instrument, the Grantee authorizes and requests Grantor to record this Release with the USPTO.

This Release shall be governed by the internal laws of the Commonwealth of Pennsylvania, without giving effect to the choice of law provisions thereof.





