RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (the "Release") is made on this 10th day of April, 2020 by Cadence Bank, N.A., in its capacity as administrative agent for a group of lenders (in such capacity, the "Administrative Agent").

WHEREAS, pursuant to (i) that certain Intellectual Property Security Agreement dated as of December 29, 2017, among Medsurant Holdings, LLC ("Holdings") and certain of its subsidiaries (together with Holdings, each a "Grantor" and collectively the "Grantors"), and Administrative Agent and (ii) that certain Intellectual Property Security Agreement dated as of March 2, 2018, among Grantors and Administrative Agent (as each of the same may have been amended, restated, supplemented or otherwise modified from time to time, collectively, the "IP Security Agreement"), the Grantors granted to the Administrative Agent a security interest in certain Intellectual Property Collateral (as defined in the IP Security Agreement). Capitalized terms used herein but not otherwise defined shall have the meaning given such terms in the IP Security Agreement;

WHEREAS, the security interest granted to the Administrative Agent under the IP Security Agreement was recorded at the United States Patent and Trademark Office on (i) December 29, 2017, at Reel 6239 and Frame 0401 and (ii) March 5, 2018, at Reel 6283 and Frame 0713, respectively; and


WHEREAS, the Administrative Agent has agreed to terminate and release all of its interest in and to all of the Intellectual Property Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Administrative Agent hereby terminates and releases all mortgages, liens, security interests and any other rights that are or may have been granted to the Administrative Agent in and to the Intellectual Property Collateral, including without limitation, any Trademarks identified on Exhibit A.
