## ARTICLES OF CONVERSION

converting

**J. J. HAINES & COMPANY, INC.**  
a Maryland corporation

to

**J.J. HAINES & COMPANY, LLC**  
a Maryland limited liability company

### THIS IS TO CERTIFY THAT:

**FIRST:** J. J. Haines & Company, Inc. is a corporation formed on December 29, 1947 under the Maryland General Corporation Law (the "Converting Corporation"), and, by virtue of these Articles of Conversion and Articles of Organization filed for record herewith, is converting (the "Conversion") to J.J. Haines & Company, LLC, a limited liability company formed under the Maryland Limited Liability Company Act (the "Converted LLC"), on the terms and conditions set forth herein.

**SECOND:** Upon the completion of the Conversion in accordance with the Maryland General Corporation Law and the Maryland Limited Liability Company Act, the Converted LLC shall, for all purposes of the laws of the State of Maryland, continue as the same entity as the Converting Corporation, and the Conversion will have the effects set forth herein and in the Maryland General Corporation Law and the Maryland Limited Liability Company Act. Upon the completion of the Conversion:

(a) The sole issued and outstanding share of common stock of the Converting Corporation, \$0.10 par value per share (the "Converting Corporation Common Share"), is held legally and beneficially by a single stockholder and shall, without any action on the part of the stockholder, be converted into and exchanged for one hundred (100) common units of limited liability company membership interest of the Converted LLC.

(b) No shares of the Converting Corporation of any class or series other than Converting Corporation Common Share are issued or outstanding.

**THIRD:** The Conversion has been approved in accordance with the provisions of Subtitle 9 of the Maryland General Corporation Law and Subtitle 11 of the Maryland Limited Liability Company Act.

**FOURTH:** These Articles of Conversion shall become effective upon acceptance for record of these Articles of Conversion by the State Department of Assessments and Taxation of Maryland.




