## ASSIGNMENT OF TRADEMARKS

S R Door, Inc., an Ohio corporation ("Assignor") owns the entire right, title and interest in and to the United States trademark, SEAL-RITE, U.S. Reg. No. 4,920,414 (the "Mark");

NOW, THEREFORE, for One Dollar and other good and valuable consideration, the receipt and adequacy of which are acknowledged, Assignor hereby assigns, transfers and conveys to The Palmer-Donavin Manufacturing Company, an Ohio corporation ("Assignee") all of its entire right, title, interest in and to the Mark (including, without limitation, the right to renew any registrations included in the Mark, the right to apply for trademark registrations within or outside the United States based in whole or in part upon the trademark, and any priority right that may arise from the trademark), the same to be held and enjoyed by Assignee as fully and entirely as said interest could have been held and enjoyed by the Assignor had this sale, assignment, transfer and conveyance not been made, together with:

- (i) the goodwill of the business connected with and symbolized by the Mark and for which the Mark was registered;
- (ii) all income, royalties, and damages hereafter due or payable to Assignor with respect to the Mark; and
- (iii) all rights to sue for pay, present and future infringement or misappropriation of the Mark.

Assignor authorizes the Commissioner of Trademarks of the United States and other empowered officials of the United States Patent and Trademark Office and in any applicable jurisdictions outside the United States to record the transfer of the foregoing U.S. Trademark to Assignee as assignee of Assignor's entire right, title and interest therein. Assignor agrees to further execute any documents reasonably necessary to affect this assignment or to confirm Assignee's ownership of the Mark.

Assignor represents and warrants that:

- (i) Assignor owns the entire right, title and interest in and to the Mark;
- (ii) the registration for the Mark is valid and subsisting and in full force and effect;
- (iii) Assignor has not licensed the Mark to any other person or entity or granted, either expressly or impliedly, any trademark or service mark rights with respect to the Mark to any other person or entity;
- (iv) there are no liens or security interests against the Mark;
- (v) Assignor has all authority necessary to enter into this Agreement and the execution and delivery of this Agreement has been duly and validly authorized; and
- (vi) execution of this Assignment and performance of Assignor's obligations hereunder shall not violate or conflict with any other agreement to which Assignor is a party or any provision of Assignor's Code of Regulations or By-laws.
