## Trademark transfer agreement

3. Assignor warrants that after the entry into force of this Agreement, it will not seek in any way any interest in the Trademarks, including title, usufruct, proceeds, disposition, and all such rights will be owned by Assignee

4. If the application for trademark is rejected by the Trademark Office, the Assignor shall return the full trademark transfer fee

5. Assignor shall ensure that the Transferred Trademark is a valid Trademark and that no third party owns the Trademarks

6. After the transfer of the trademark right, Assignee's authority:

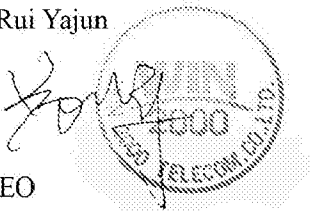
