

Assignee was desirous of acquiring the Mark and all rights, title and interest owned in the Mark by Assignor, including the associated goodwill.

Therefore, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby acknowledges that effective October 1, 2018 (the “**Effective Date**”) it did assign to Assignee, and confirms nunc pro tunc that Assignor did so assign on the Effective Date all right, title and interest in the United States in and to the Mark shown in Schedule A, together with the goodwill of the business symbolized by such Mark, and any registrations for the Mark, along with the right to recover and have damages and profits for past and current infringements, if any.

This Assignment may be executed in one or more counterparts, each of which when executed shall be deemed to be an original instrument and all of which taken together shall constitute one and the same agreement.

NOW THEREFORE, Assignor and Assignee have caused this Assignment to be executed by duly authorized signatories.


