TRADEMARK RELEASE

THIS TRADEMARK RELEASE is made as of April 17, 2020, by TC LENDING, LLC, as Collateral Agent for the Secured Parties ("Collateral Agent"). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

WITNESSETH:

WHEREAS, CAPSULE TECHNOLOGIES, INC. (f/k/a Qualcomm Life, Inc.), a California corporation ("Grantor") and Collateral Agent were parties to that certain Trademark Security Agreement dated as of February 11, 2019 (the "Security Agreement") pursuant to which the Grantor granted a security interest to Collateral Agent in certain Trademarks and Trademark Collateral (as defined below) as security for certain obligations owing by Grantor to Collateral Agent, including the Trademarks set forth on Schedule 1 hereto;

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on February 11, 2019, at Reel 006556, Frame 0791; and

WHEREAS, Grantor has requested that Collateral Agent release its security interest in the Trademarks and Trademark Collateral.
