RELEASE OF SECOND LIEN SECURITY INTEREST IN TRADEMARKS (FIRST SUPPLEMENT)

This RELEASE OF SECOND LIEN SECURITY INTEREST IN TRADEMARKS (FIRST SUPPLEMENT), dated as of April 14, 2020 (this "Release") is made by CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH, as Second Lien collateral agent (in such capacity, the "Second Lien Collateral Agent") in favor of TIERPOINT, LLC, a Delaware limited liability company with offices at 12444 Powerscourt Drive, Suite 450, St. Louis, MO 63131, and TIERPOINT HOSTED SOLUTIONS, LLC, a Delaware limited liability company with offices at 12444 Powerscourt Drive, Suite 450, St. Louis, MO 63131 (each a "Grantor," and together the "Grantors"). Capitalized terms used but not otherwise defined herein shall have the meanings given to them, directly or by reference, in the Second Lien Trademark Security Agreement (as defined below).

WITNESSETH:

WHEREAS, in connection with the Second Lien Credit Agreement, dated as of December 2, 2014 among the Administrative Agent and the Grantors and the other parties thereto (as may have been amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Second Lien Credit Agreement"), the Grantors entered into that certain Second Lien Pledge and Security Agreement dated as of December 2, 2014 (as may have been amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Second Lien Pledge and Security Agreement");

WHEREAS, pursuant to the Second Lien Pledge and Security Agreement, the Grantors executed and delivered that certain Second Lien Trademark Security Agreement First Supplemental Filing, dated as of May 5, 2017 (the "Second Lien Trademark Security Agreement") in favor of the Second Lien Collateral Agent;

WHEREAS, pursuant to the Second Lien Trademark Security Agreement, and as security for the payment or performance, as the case may be, in full of the Secured Obligations, each Grantor granted to the Second Lien Collateral Agent, its successors and assigns, for the benefit of the Secured Parties, a security interest (the "Security Interest") in all of such Grantor's right, title and interest in, to and under any and all of the following assets then owned or at any time thereafter acquired by such Grantor or in which such Grantor then had or at any time thereafter may have acquired any right, title or interest, but excluding any Excluded Assets (collectively, the "Trademark Collateral"): (a) all Trademarks of such Grantor, including, without limitation, the registered and applied-for Trademarks of such Grantor listed on Schedule 1 attached hereto, and (b) all Proceeds of any of the foregoing;

WHEREAS, the Second Lien Trademark Security Agreement was recorded in the United States Patent and Trademark Office on June 14, 2017 at Reel/Frame 6084/0361 (with respect to Tierpoint, LLC) and at Reel/Frame 6084/0369 (with respect to Tierpoint Hosted Solutions, LLC); and

WHEREAS the Grantors have requested that the Second Lien Collateral Agent now terminate and release its Security Interest in the Trademark Collateral.

NOW THEREFORE, in consideration of the foregoing and for other good and valuable consideration the receipt and adequacy of which are hereby acknowledged, the Second Lien Collateral Agent hereby terminates the Trademark Security Agreement, and hereby terminates and releases the Security Interest in the Trademark Collateral, without representation or warranty of any kind, and without recourse to the First Lien Collateral Agent.

Each Grantor (and any successor to such Grantor, including any person or entity hereafter holding any right, title or interest in and to the Trademark Collateral of such Grantor) is hereby authorized to record this Release with the United States Patent and Trademark Office with respect to the Trademark Collateral of such Grantor, at such Grantor's expense.
