Assignor does hereby irrevocably transfer, sell, assign and convey unto Assignee and its successors and assigns, Assignor's entire right, title and interest throughout the world in and to the Marks (including any common law rights that may exist and are associated therewith), together with the goodwill of the business symbolized thereby and appurtenant thereto, the same to be held and enjoyed by Assignee, its successors and assigns, together with income, royalties, damages or payments due on or after the date hereof, including, without limitation, all claims Assignor may have against any party for damages or payments by reason of infringement or unauthorized use of the Marks, whether choate or inchoate, known or unknown, contingent or non-contingent, along with the right to sue for past infringement, dilution, misappropriation, or violation thereof, including the right to collect and retain all proceeds and damages therefrom.

2. Assignor does hereby authorize the Director of the United States Patent & Trademark Office, and the empowered official of any U.S. State, or any country or countries foreign to the United States whose duty it is to record trademark registrations, applications and title thereto, to record the Marks and title thereto as the property of Assignee, its successors and assigns in accordance with the terms of this instrument.

3. Each party hereto will, from time to time, execute and deliver to the other party all such other and further instruments and documents and take or cause to be taken all such other and further action as Assignee may reasonably request in order to effect and confirm the transactions contemplated by this Assignment.

4. This Assignment will be governed by and construed in accordance with the laws of the State of Florida, without giving effect to any choice of conflict of law provision or rule that would cause the application of the laws of any other jurisdiction.

5. This Assignment constitutes the sole and entire agreement of the parties with respect to the subject matter contained herein and therein, and supersedes all prior and

contemporaneous understandings and agreements, both written and oral, with respect to such subject matter.


6. This Assignment may only be amended, modified, or supplemented by an agreement in writing signed by each party hereto, and any of the terms thereof may be waived, only by a written document signed by each party to this Assignment or, in the case of waiver, by the party or parties waiving compliance.

7. This Assignment may be executed in multiple counterparts, each of which shall be deemed an original and all of which together shall constitute one instrument. A signed copy of this Assignment delivered by facsimile, email, or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Assignment.



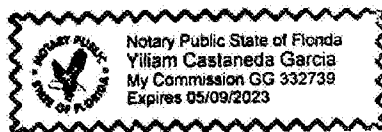

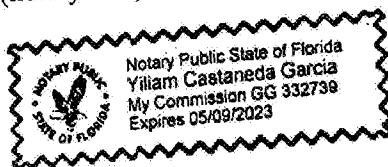
